



1) Work Area Safety

- a) **Keep work area clean and well lit.** Cluttered or dark areas invite accidents.
- b) Do not operate power tools in explosive atmospheres, such as in the presence of flammable liquids, gases or dust. Power tools create sparks which may ignite the dust or fumes.
- c) Keep children and bystanders away while operating a power tool. Distractions can cause you to lose control.

2) Electrical Safety

- a) Power tool plugs must match the outlet. Never modify the plug in any way. Do not use any adapter plugs with earthed (grounded) power tools.

Chargers

DEWALT chargers require no adjustment and are designed to be as easy as possible to operate.

Electrical Safety

The electric motor has been designed for one voltage only. Always check that the battery pack voltage corresponds to the voltage on the rating plate. Also make sure that the voltage of your charger corresponds to that of your mains.



Your DEWALT charger is double insulated in accordance with EN60335; therefore, no earth wire is required.

If the supply cord is damaged, it must be replaced only by DEWALT or an authorised service organisation.

Mains Plug Replacement (U.K. & Ireland Only)

If a new mains plug needs to be fitted:

- Safely dispose of the old plug.
- Connect the brown lead to the live terminal in the plug.
- Connect the blue lead to the neutral terminal.



WARNING: No connection is to be made to the earth terminal

Follow the fitting instructions supplied with good quality plugs. Recommended fuse: 3 A.

Using an Extension Cable

An extension cord should not be used unless absolutely necessary. Use an approved extension cable suitable for the power input of your charger (refer to *Technical Data*). The minimum conductor size is 1 mm²; the maximum length is 30 m. When using a cable reel, always unwind the cable completely.

Important Safety Instructions for All Battery Chargers

SAVE THESE INSTRUCTIONS: This manual contains important safety and operating instructions for compatible battery chargers (refer to **Technical Data**). Before using charger, read all instructions and cautionary markings on charger, battery pack, and product using battery pack.



WARNING: Shock hazard. Do not allow any liquid to get inside charger. Electric shock may result.



WARNING: We recommend the use of a residual current device with a residual current rating of 30 mA or less.



CAUTION: Burn hazard. To reduce the risk of injury, charge only DEWALT rechargeable batteries. Other types of batteries may burst, causing personal injury and damage.



CAUTION: Children should be supervised to ensure that they do not play with the appliance.

NOTICE: Under certain conditions, with the charger plugged into the power supply, the exposed charging contacts inside the charger can be shorted by foreign material. Foreign materials of a conductive nature such as, but not limited to, steel wool, aluminum foil or any buildup of metallic particles should be kept away from charger cavities. Always unplug the charger from the power supply when there is no battery pack in the cavity. Unplug charger before attempting to clean.

- DO NOT attempt to charge the battery pack with any chargers other than the ones in this manual. The charger and battery pack are specifically designed to work together.
- These chargers are not intended for any uses other than charging DEWALT rechargeable batteries. Any other uses may result in risk of fire, electric shock or electrocution.
- Do not expose charger to rain or snow.
- Pull by plug rather than cord when disconnecting charger. This will reduce risk of damage to electric plug and cord.
- Make sure that cord is located so that it will not be stepped on, tripped over, or otherwise subjected to damage or stress.
- Do not use an extension cord unless it is absolutely necessary. Use of improper extension cord could result in risk of fire, electric shock, or electrocution.
- Do not place any object on top of charger or place the charger on a soft surface that might block the ventilation slots and result in excessive internal heat.
 Place the charger in a position away from any heat source. The charger is ventilated through slots in the top and the bottom of the housing.
- Do not operate charger with damaged cord or plug have them replaced immediately.
- Do not operate charger if it has received a sharp blow, been dropped, or otherwise damaged in any way. Take it to an authorised service centre.
- Do not disassemble charger; take it to an authorised service centre when service or repair is required. Incorrect reassembly may result in a risk of electric shock, electrocution or fire.
- In case of damaged power supply cord, the supply cord must be replaced immediately by the manufacturer, its service agent or similar qualified person to prevent any hazard.
- Disconnect the charger from the outlet before attempting any cleaning. This will reduce the risk of electric shock.
 Removing the battery pack will not reduce this risk.
- NEVER attempt to connect two chargers together.
- The charger is designed to operate on standard 230V household electrical power. Do not attempt to use it on any other voltage. This does not apply to the vehicular charger.

Charging a Battery (Fig. B)

- 1. Plug the charger into an appropriate outlet before inserting battery pack.
- Insert the battery pack 15 into the charger, making sure the battery pack is fully seated in the charger. The red (charging) light will blink repeatedly, indicating that the charging process has started.
- 3. The completion of charge will be indicated by the red light remaining ON continuously. The battery pack is fully charged and may be used at this time or left in the charger. To remove the battery pack from the charger, push the battery release button 16 on the battery pack.

NOTE: To ensure maximum performance and life of lithium-ion battery packs, charge the battery pack fully before first use.

Charger Operation

Refer to the indicators below for the charge status of the battery pack.



*The red light will continue to blink, but a yellow indicator light will be illuminated during this operation. Once the battery pack has reached an appropriate temperature, the yellow light will turn off and the charger will resume the charging procedure.

The compatible charger(s) will not charge a faulty battery pack. The charger will indicate faulty battery by refusing to light. **NOTE:** This could also mean a problem with a charger.

If the charger indicates a problem, take the charger and battery pack to be tested at an authorised service centre.

Hot/Cold Pack Delay

When the charger detects a battery pack that is too hot or too cold, it automatically starts a Hot/Cold Pack Delay, suspending charging until the battery pack has reached an appropriate temperature. The charger then automatically switches to the pack charging mode. This feature ensures maximum battery pack life.

A cold battery pack will charge at a slower rate than a warm battery pack. The battery pack will charge at that slower rate throughout the entire charging cycle and will not return to maximum charge rate even if the battery pack warms.

The DCB118 charger is equipped with an internal fan designed to cool the battery pack. The fan will turn on automatically when the battery pack needs to be cooled. Never operate the charger if the fan does not operate properly or if ventilation slots are blocked. Do not permit foreign objects to enter the interior of the charger.

Electronic Protection System

XR Li-lon tools are designed with an Electronic Protection System that will protect the battery pack against overloading, overheating or deep discharge. The tool will automatically turn off if the Electronic Protection System engages. If this occurs, place the lithium-ion battery pack in the charger until it is fully charged.

Wall Mounting

These chargers are designed to be wall mountable or to sit upright on a table or work surface. If wall mounting, locate the charger within reach of an electrical outlet, and away from a corner or other obstructions which may impede air flow. Use the back of the charger as a template for the location of the mounting screws on the wall. Mount the charger securely using drywall screws (purchased separately) at least 25.4 mm long with a screw head diameter of 7–9 mm, screwed into wood to an optimal depth leaving approximately 5.5 mm of the screw exposed. Align the slots on the back of the charger with the exposed screws and fully engage them in the slots.

Charger Cleaning Instructions



WARNING: Shock hazard. Disconnect the charger from the AC outlet before cleaning. Dirt and grease may be removed from the exterior of the charger using a cloth or soft non-metallic brush. Do not use water or any cleaning solutions. Never let any liquid get inside the tool; never immerse any part of the tool into a liquid.

Battery Packs

Important Safety Instructions for All Battery Packs

When ordering replacement battery packs, be sure to include catalogue number and voltage.

The battery pack is not fully charged out of the carton. Before using the battery pack and charger, read the safety instructions below. Then follow charging procedures outlined.

READ ALL INSTRUCTIONS

- Do not charge or use battery in explosive atmospheres, such as in the presence of flammable liquids, gases or dust. Inserting or removing the battery from the charger may ignite the dust or fumes.
- Never force battery pack into charger. Do not modify battery pack in any way to fit into a non-compatible charger as battery pack may rupture, causing serious personal injury.
- Charge the battery packs only in DEWALT chargers.
- **DO NOT** splash or immerse in water or other liquids.
- Do not store or use the tool and battery pack in locations where the temperature may fall below 4 °C (39.2 °F) (such as outside sheds or metal buildings in winter), or reach or exceed 40 °C (104 °F) (such as outside sheds or metal buildings in summer).
- Do not incinerate the battery pack even if it is severely damaged or is completely worn out. The battery pack can explode in a fire. Toxic fumes and materials are created when lithium-ion battery packs are burned.
- If battery contents come into contact with the skin, immediately wash area with mild soap and water. If battery liquid gets into the eye, rinse water over the open eye for 15 minutes or until irritation ceases. If medical attention

- is needed, the battery electrolyte is composed of a mixture of liquid organic carbonates and lithium salts.
- Contents of opened battery cells may cause respiratory irritation. Provide fresh air. If symptoms persist, seek medical attention.



WARNING: Burn hazard. Battery liquid may be flammable if exposed to spark or flame.



WARNING: Never attempt to open the battery pack for any reason. If battery pack case is cracked or damaged, do not insert into charger. Do not crush, drop or damage battery pack. In general, only shipments containing a lithium-ion battery with an energy rating greater than 100 Watt Hours (Wh) will require being shipped as fully regulated Class 9. All lithium-ion batteries have the Wh rating marked on the pack. Furthermore, due to regulation complexities, DEWALT does not recommend air shipping lithium-ion battery packs alone regardless of Wh rating. Shipments of tools with batteries (combo kits) can be air shipped as excepted if the Wh rating of the battery pack is no greater than 100 Wh.

Regardless of whether a shipment is considered excepted or fully regulated, it is the shipper's responsibility to consult the latest regulations for packaging, labeling/marking and documentation requirements.

Transporting the FLEXVOLT™ Battery

The DEWALT FLEXVOLT® battery has two modes: **Use** and **Transport**.

Use Mode: When the FLEXVOLT[™] battery stands alone or is in a DEWALT 18V product, it will operate as an 18V battery. When the FLEXVOLT[™] battery is in a 54V or a 108V (two 54V batteries) product, it will operate as a 54V battery.

Transport Mode: When the cap is attached to the FLEXVOLTTM battery, the battery is in Transport mode. Keep the cap for shipping.

When in Transport mode, strings of cells are electrically disconnected within the pack, resulting in 3 batteries with a



lower Watt hour (Wh) rating as compared to 1 battery with a higher Watt hour rating. This increased quantity of 3 batteries with the lower Watt hour rating can exempt the pack from certain shipping regulations that are imposed upon the higher Watt hour batteries.

For example, the Transport Wh rating might indicate 3 x 36 Wh, meaning 3 batteries of 36 Wh each. The Use Wh rating might

For example, the Transport Example of Use and Transport Label Marking



indicate 108 Wh (1 battery implied).

Storage Recommendations

- The best storage place is one that is cool and dry away from direct sunlight and excessive heat or cold. For optimum battery performance and life, store battery packs at room temperature when not in use.
- For long storage, it is recommended to store a fully charged battery pack in a cool, dry place out of the charger for optimal results.

NOTE: Battery packs should not be stored completely depleted of charge. The battery pack will need to be recharged before use.

Labels on Charger and Battery Pack

ASSEMBLY AND ADJUSTMENTS



WARNING: To reduce the risk of serious personal injury, turn tool off and disconnect battery pack before making any adjustments or removing/installing attachments or accessories. An accidental start-up can cause injury.



WARNING: Use only DEWALT batteries and chargers.

Inserting and Removing the Battery Pack from the Tool (Fig. B)

NOTE: Make sure your battery pack **8** is fully charged.

To Install the Battery Pack into the Tool Handle

- 1. Align the battery pack with the rails inside the tool's handle (Fig. B).
- Slide it into the handle until the battery pack is firmly seated in the tool and ensure that you hear the lock snap into place.

To Remove the Battery Pack from the Tool

- 1. Press the battery release button **9** and firmly pull the battery pack out of the tool handle.
- 2. Insert battery pack into the charger as described in the charger section of this manual.

Fuel Gauge Battery Packs (Fig. B)

Some DEWALT battery packs include a fuel gauge, which consists of three green LED lights that indicate the level of charge remaining in the battery pack.

To actuate the fuel gauge, press and hold the fuel gauge button (12). A combination of the three green LED lights will illuminate, designating the level of charge left. When the level of charge in the battery is below the usable limit, the fuel gauge will not illuminate and the battery will need to be recharged.

NOTE: The fuel gauge is only an indication of the charge left on the battery pack. It does not indicate tool functionality and is subject to variation based on product components, temperature and end-user application.

OPERATION

Instructions for Use



WARNING: Always observe the safety instructions and applicable regulations.



WARNING: To reduce the risk of serious personal injury, turn tool off and disconnect battery pack before making any adjustments or removing/installing attachments or accessories. An accidental start-up can cause injury.

Proper Hand Position (Fig. D)



WARNING: To reduce the risk of serious personal injury, **ALWAYS** use proper hand position as shown.



WARNING: To reduce the risk of serious personal injury, **ALWAYS** hold securely in anticipation of a sudden reaction.

Proper hand position requires one hand on the main handle 3 and one hand on the bail handle 5. Never hold the unit by the blade guard 6.

Switching On (Fig. A, C, D)



WARNING: Never attempt to lock a switch in the ON position.

- Squeeze the bail handle switch 4 and the bail handle 5 with one hand so that the bail handle switch 4 is pushed into the body of the bail handle 5.
- Push the lock off switch 2 forward and squeeze the trigger switch 1. Once the unit is running, you may release the lock off switch.
- 3. In order to keep the unit running you must continue to squeeze the bail handle switch 4 and trigger switch 1.
- 4. To turn the unit off, release the trigger switch 1.

Trimming Instructions (Fig. C–G)



DANGER: Keep hands away from blade.



WARNING: To guard against injury, observe the following:

- Read instruction manual before using. Save instruction manual.
- Check the hedge for foreign objects such as wires or fences before each use.
- Keep hands on handles. Don't overreach.
- Do not use under wet conditions.



CAUTION: Blade may coast after turn off.



CAUTION: Do not use blade to cut stems greater than 32 mm. Use the trimmer only for cutting normal shrubbery around houses and buildings.

Working Position (Fig. D)

Maintain proper footing and balance and do not overreach. Wear safety goggles, non-skid footwear and gloves when trimming. Hold the tool firmly in both hands and turn the tool ON. Always hold the trimmer, as shown in Fig. D. Refer to **Proper Hand Position** for more information. Never hold the tool by the blade guard.

Trimming New Growth (Fig. E)

Using a wide, sweeping motion and feeding the blade teeth through the twigs, is most effective. A slight downward tilt of the blade in the direction of motion gives the best cutting.

Level Hedges (Fig. F)

To obtain exceptionally level hedges a piece of string can be stretched along the length of the hedge as a guide.

Side Trimming Hedges (Fig. G)

Position the trimmer as shown and begin at the bottom and sweep upwards.

MAINTENANCE

Your power tool has been designed to operate over a long period of time with a minimum of maintenance. Continuous satisfactory operation depends upon proper tool care and regular cleaning.



WARNING: To reduce the risk of serious personal injury, turn tool off and disconnect battery pack before making any adjustments or removing/installing attachments or accessories. An accidental start-up can cause injury.

The charger and battery pack are not serviceable.

Blade Maintenance (Fig. H)

The cutting blades are made from high quality, hardened steel and with normal usage, they will not require resharpening. However, if you accidentally hit a wire fence (Fig. H), stones, glass, or other hard objects, you may put a nick in the blade. There is no need to remove this nick as long as it does not interfere with the movement of the blade. If it does interfere, remove the battery and use a fine toothed file or sharpening stone to remove the nick. If you drop the trimmer, carefully inspect it for damage. If the blade is bent, housing cracked, handles broken or if you see any other condition that may affect the tool's operation contact your local authorized service center for repairs before putting it back into use.

Blade Lubrication (Fig. A)

- 1. After use, remove the battery 8.
- 2. Carefully apply a resin solvent to the exposed blades.
- Insert the battery and turn the tool vertical with the blades toward the ground and run the tool for a few seconds to fully disperse the lubrication.

Storage (Fig. A)

- 1. After use, remove the battery.
- Keeping your hands away from the blade, slide the blade cover 10 over the blade until it snaps into place as shown in Fig. A.

Lubrication

Your power tool requires no additional lubrication.

Cleaning



WARNING: Electrical shock and mechanical hazard. Disconnect the electrical appliance from the power source before cleaning.



WARNING: To ensure safe and efficient operation, always keep the electrical appliance and the ventilation slots clean.



WARNING: Never use solvents or other harsh chemicals for cleaning the non-metallic parts of the tool. These chemicals may weaken the materials used in these parts.

Use a cloth dampened only with water and mild soap. Never let any liquid get inside the tool; never immerse any part of the tool into a liquid.

Ventilation slots can be cleaned using a dry, soft non-metallic brush and/or a suitable vacuum cleaner. Do not use water or any cleaning solutions. Wear approved eye protection and an approved dust mask.
